

In 2017, there were 7 fields of technical activity: Accessibility, Child Safety, Digital Society, Domestic Appliances, Services, Sustainability, and Traffic & Mobility.



#### **CHILD SAFETY**

Children are among the most vulnerable consumers. The driving force behind ANEC's work is to enhance the quality and safety of children's lives by ensuring that European standards and legislation offer the highest levels of protection.



#### **ACCESSIBILITY**

It is a basic right to have access to products and services. Discrimination arises when older people and people with disabilities cannot use mainstream consumer products and services. Standards can help overcome this prejudice if Design for All principles are applied.



#### **DOMESTIC APPLIANCES**

Consumers still suffer injuries – sometimes fatal - in accidents caused by faulty appliances. ANEC participates in the standardisation of domestic appliances to avoid accidents and ensure appliances can be used safely by all consumers. We also aim to improve energy efficiency.



#### **DIGITAL SOCIETY**

ICT products and services - such as mobile phones and the Internet - play an essential role in our daily lives. ANEC strives to ensure the safety, accessibility, interoperability and privacy of ICT products & services, especially noting the risks posed by connected products and the Internet of Things.



#### **SUSTAINABILITY**

Many consumers are increasingly basing their purchasing decisions not only on quality, price and availability, but also on environmental and social impacts. Sustainability plays a significant role in today's consumer product policy and standards.



#### **SERVICES**

In today's service-oriented economy, ANEC aims to ensure the safety and quality of services for all consumers. We contribute to standards that reduce the potential risks of certain services – such as healthcare and tourism – and increase the quality provisions of services of general interest.



#### **TRAFFIC & MOBILITY**

ANEC addresses both the active and passive aspects of road safety. These include ensuring child-restraints systems provide the highest levels of safety practicable; that road safety measures cover vulnerable consumers; that traditional and newer powered-forms of bicycles are safe, and that environmental priorities do not jeopardise the safety of motor vehicles or road users.




### **KEY EVENTS IN 2017**




#### A Right of Opinion on draft standards

CEN and CENELEC granted ANEC, ECOS & ETUC - the European Societal Stakeholder Organisations recognised under Annex III of Regulation (EU) 1025/2012 - the right to submit an Opinion on draft standards sent to Enquiry or Formal Vote. The right was implemented on 1 January 2017. Although the Opinion is not a vote, it is a notable step towards greater inclusiveness and a key achievement for ANEC.

In 2017, ANEC submitted a total of 63 opinions, 47 "Favourable" and 16 "Not Favourable".

### ETSI opens doors to consumers

ETSI introduces the 3SI Programme: Societal Stakeholders, SMEs and Inclusiveness. The 3SI programme aims to promote the interests of societal stakeholders and SMEs in ETSI standardisation work.

ANEC expert, John Ketchell, was elected the first 3SI Advocate in November 2017. The 3SI Advocate is to champion the Programme, and be the main point of contact.








#### **AUWP 2018**

ANEC issues a position paper on the Annual Union Work Programme (AUWP) for European Standardisation 2018 with our views on general aspects of consumer relevance, as well as on the actions to be implemented in 2018. We focus especially on actions in support of the Digital Single Market Strategy, deeper and fairer Internal Market, Inclusiveness, and the Joint Initiative on Standardisation (JIS).









### Parliament supports societal participation

On 4 July, the European Parliament adopted a Resolution "European Standards for the 21st Century". A key recommendation is for the European Commission to ensure it maintains resources to fulfil the objectives of Regulation (EU) 1025/2012 on European standardisation, including the inclusiveness of the process.

#### Stricter checks on goods

On 19 December, ANEC welcomed the European Commission proposal to enhance checks on certain consumer goods in the EU, such as toys, phones or TVs. It answers concerns that too many unsafe products are on sale in the Single Market. Unfortunately, the proposal fails to address other consumer products, including cots for babies and pedal cycles.

### ANEC INVESTIGATES CROSS-BORDER HEALTHCARE

#### **KEY FACTS: Cross-border healthcare**



### Accessing medical treatment in other EU countries: Consumer attitudes and experiences

European legislation gives EU citizens the right to access planned and unplanned medical treatment in other EU countries, under certain conditions.

We surveyed **1,656 European consumers** during August and September 2017 to learn about their experiences with cross-border healthcare.



**37%** had received unplanned medical treatment in another country



**4%** had travelled abroad specifically to receive planned medical care

ANEC commissioned a **Technical Study on cross-border healthcare** that investigates consumers' experience using healthcare services (planned and unplanned) in a European country other than their home country. It showed that a majority of consumers are still reluctant to seek planned medical treatment in other EU countries despite the Cross-border Healthcare Directive being in place for almost 5 years.

It also revealed a lack of knowledge about rights and choices is a key barrier to seeking treatment abroad, and highlights the need to raise awareness of rights and provide patients with clear guidance on cross-border healthcare options.

### Removal of the 'exclusion clause' moves to IEC

After much work by ANEC, standards for the safety of electrical domestic appliances that did not adequately address the needs of vulnerable users have now been - or are close to being - amended by CENELEC. Given the interrelationship between CENELEC and IEC standards, ANEC is extending its initiative to remove the "exclusion clause" to the international level. As a first step, the study contractor carried out a gap analysis to identify the modified requirements of the European standards that will need to be proposed as amendments to the IEC 60335 Part 2 series of standards. We shall continue this work in 2018.

#### ANEC scores on standard for moveable goal posts

Children in the EU have suffered very serious – and sometimes fatal - head injuries from the fall of non-fixed goal posts. For many years, ANEC has voiced its concern as the European standard for football goalposts dealt only with goalposts used during organised activities.

In response, CEN TC 136 WG 22 'Gymnastic equipment' agreed in 2010 to work on new and separate European standards for portable goals. *EN 16579 'Playing field equipment - Portable and permanent socketed goals - Functional, safety requirements and test methods'* was adopted in October 2017. A first standard, EN 16664 'Playing field equipment — Lightweight goals — Functional, safety requirements and test methods', was adopted in April 2015. ANEC played a full role in development of both standards.

#### Further standard on child protective products

ANEC welcomed the adoption by CEN of EN 16948 'Child protective products – Consumer-fitted child-resistant locking devices for cupboards and drawers - Safety requirements and test methods'. These devices keep a drawer or cupboard door closed, or restrict its opening by young children. The technical committee responsible, CEN/TC 398, originated as CEN/BT WG 184 which arose from recommendations of a research project commissioned by ANEC on child protective products.

### **ACCESSIBILITY**



#### MAKING EUROPE ACCESSIBLE

On 14 September, the European Parliament adopted the proposal for a European Accessibility Act. With the Council agreeing its position in December, negotiations could start under the Bulgarian Presidency. Although the Parliament accepted several improvements to the text, in line with the ANEC position, we regret other changes focus on reducing burdens for economic operators and public authorities. Nevertheless, standards are still foreseen as the main means of demonstrating presumption of conformity to the legal requirements.

Regarding Directive (EU) 2016/2102 on web accessibility, in May 2017, we supported approval of a Standardisation Request for Harmonised Standards to support the directive. As well as helping develop the accessibility requirements for mobile apps and websites as members of the Expert Group advising the Commission, we are contributing to the Harmonised Standards. We welcome that requirements for products & services that meet the needs of persons with cognitive and learning disabilities will be considered in these standards, as ANEC was at the origin of ETSI standards on cognitive impairments published in 2016.

#### Safer medical beds for children with disabilities

ANEC welcomed the publication in December by CENELEC of EN 50637:2017 'Medical electrical equipment - Particular requirements for the basic safety and essential performance of medical beds for children', as it offers a high level of child protection and so can assure parents that children with disabilities will be moved safely when in hospital. Many advances in the standard were proposed by ANEC.

### Accessibility must not depend on aesthetics

ANEC appealed in July 2017 against ratification of **EN 81-70** 'Safety rules for the construction and installation of lifts. Particular applications for passenger and goods passenger lifts. Accessibility to lifts for persons including persons with disability'. We did not agree with a change of contrast requirement for symbols on push buttons, introduced after the Enquiry phase, mainly because of aesthetics considerations. The appeal was heard by a conciliation panel in October. It invited CEN to approach the EC Joint Research Centre (JRC) for a study related to the accessibility requirements for lifts regarding the visual contrast in control panels. Unfortunately, the JRC declined to carry out the study.

Separately, the CEN Technical Board decided to proceed with publication of the revised **EN 81-70** (and we accept it contains improvements for persons with disabilities, apart from the issue of contrast value). Nevertheless, we will maintain the appeal. We believe a point of principle is at stake which is that a standard for accessibility fails to address the needs of the community of people with visual disabilities and older persons.

#### **STORIES:**

- Surface temperature limits have been of great concern to ANEC. The industry has resisted compliance of products with the lower limits of CENELEC Guide 29 (& IEC Guide 117). After much pressure from ANEC, CENELEC TC 61 accepted an EC Implementing Decision, upholding a Formal Objection against EN 60335-2-9 on grills and toasters, which could require the review of all similar standards. This decision is an achievement for ANEC and could lead to the reduced risks of burns or other serious injury, notably among vulnerable consumers. A task force has been created to establish temperature limits that address the Formal Objection. ANEC participates in the work, which started in August 2017.
- ANEC welcomed the adoption by CEN of EN 1860-1/A1
   'Appliances, solid fuels and firelighters for barbecuing Part 1:
   Barbecues burning solid fuels Requirements & test methods'.
   The amendment introduces a safety symbol to appear on barbecues warning consumers not to use barbeques indoors because of the risk of carbon monoxide poisoning.
- Following various 'white goods' fires in the UK, caused by refrigerators and other electrical household appliances, that led to a high number of fatalities, ANEC supported a proposal from the British Electrotechnical Committee to CENELEC to revise EN 60335-2-24: 2010/prA2:2017 'Household and similar electrical appliances Safety Part 2-24: Particular requirements for refrigerating appliances, ice-cream appliances and ice-makers'. ANEC met on this issue with its UK experts, the Electrical Safety First charity and the London Fire Brigade. Work will continue in 2018.

ANEC also welcomed the **European Commission creating the European Fire Information Exchange Platform (FIEP)**. Its
purpose is to promote cooperation between Member States and
stakeholders in order to aid knowledge transfer and the sharing
of good practice. We look forward to contributing to the FIEP.



### ANEC WINS SUPPORT FOR ACTION ON PRIVACY AND SECURITY

ANEC welcomed the support of Member States in 2017 for our proposal for an EC delegated act to make personal data protection an essential requirement under the Radio Equipment Directive (2014/53/EU). Harmonised Standards could support these requirements and offer privacy and security-by-design. Our proposal helps answer the #toyfail campaign which showed internet-connected products are not secure. In the example cited by the Norwegian Consumer Council (NCC), the NCC showed it was possible to hack two internet-connected toys (Cayla and i-Que) using a Bluetooth connection.

In October, ANEC was part of action against children's smart watches. These have been shown to put children's safety and privacy at risk. The watches, intended to provide parents with peace of mind, are wearable mobile phones that use the internet and GPS to allow real-time tracking of children, and communication with them. An NCC study showed a hacker can take control


of a smartwatch to track, listen, or talk to the child, all without a parent's knowledge.


### ENSURING THE SAFETY OF MOBILE DEVICES

ANEC welcomes the publication of CENELEC standards on human exposure to electromagnetic fields (EMF) from mobile phones, RFID devices and broadcasting antennas. These require the products be tested under conditions of "reasonably foreseeable use". When dealing with the exposure to Electro Magnetic Fields (EMF) from mobile phones, we believe it is not enough to consider only the final purpose of the product in the design phase: it is also important to take into account how and under what conditions consumers will likely use the product. This is the so-called "foreseeable use". Only then can consumers be adequately protected.

The new standards, developed by CENELEC's Technical Committee 106X on 'Electromagnetic fields in the human environment' in which ANEC participates, refer to established international safety limits that protect consumers using smart phones and similar devices.







#### **BACK TO A SIMPLE A-G ENERGY LABEL SCHEME!**

ANEC has campaigned for a change to the Energy Label so that it can help consumers make the most sustainable decisions in their purchasing more easily, and encourage manufacturers to innovate in making ever more energy-efficient products. In 2015, the Commission put forward a good proposal which responded to some of ANEC's asks. We had insisted on the need to bring all existing product labels into the closed A-G scale, and stressed the motivational power of a simple energy label where "A is best". After 2 years of negotiations, which ANEC followed closely, the three EU institutions struck a deal in 2017 on the EU Energy label. The well-known A-G scale will return to the shops as a result.

Although it is disappointing that consumers will have to wait years before seeing the new label on some products, an online database will be created to inform consumers which models need to feature the Energy Label. We think this will increase transparency to consumers and help them choose the products that best serve their needs. ANEC and BEUC issued a leaflet.

#### STANDARDS FOR ENERGY-RELATED PRODUCTS

ANEC signed a contract in December 2017 to continue working with ECOS for a further 15 months on an Ecodesign and energy-related standardisation project responding to Action 36 of the H2020 Work Programme 2016-2017: 'Technical support to stakeholders on standardisation work for energy related products'.



### **SMART METERING**



By 2020, it is expected that almost 72% of European consumers will have a smart meter for electricity.

A new study, commissioned by the EC and prepared in 2017, defines a set of key-performance indicators (KPIs) that cover the four dimensions suggested by ANEC in its 2015 position paper 'Monitoring the success of smart metering deployment from a consumer perspective':

- 1. easy access to usable consumption information
- 2. high level of satisfaction with smart metering deployment

- 3. benefit realisation
- 4. active engagement in the European energy market

The study recommends considering these KPIs as a starting point in a discussion on defining a framework to monitor and compare the impact of smart metering roll-out across Member States. We trust these efforts will result in a greater focus on improving consumer experience and engagement with smart meters.



### **SERVICES**

#### **CORE ACTIVITIES IN 2017:**

#### HORIZONTAL SERVICES STANDARDISATION





ANEC contributed to the revision of ISO/IEC Guide 76 'Development of service standards – Recommendations for addressing consumer issues'

#### DIGITAL SERVICES



ANEC and Consumers International collaborated on protecting consumers in the new business models arising from the sharing economy and e-commerce. We developed an ANEC/CI position paper on the sharing economy to contribute to the new International Workshop Agreement 27 on Sharing Economy published in September 2017.

An ANEC expert continued to represent ANEC and CI in the development of **ISO/ DIS 20488 'Online consumer reviews - Principles and requirements for their collection, moderation and publication'.** We trust the resulting standard will offer a code of conduct that can contribute to increased transparency in the sector.





ANEC published a **position paper** on consumer expectations from the proposal for a EU Regulation for cross-border parcel delivery services.

In December 2017, the Estonian Presidency announced agreement between Parliament and Council on the proposed **Regulation on cross-border parcel delivery.** Traders will have to provide consumers with clear information on prices charged for cross-border parcel delivery, and use of complaints procedures. European standards will support implementation of the new Regulation which is expected to be adopted by mid-2018.

ANEC contributed to improving draft ISO standards on medical spas and accessible tourism (ISO/WD 21902 'Tourism and related services – Accessible tourism for all – Requirements and recommendations').

#### **STORIES:**

### PRIORITISATION OF SERVICES STANDARDISATION

ANEC provided the consumer view in the drafting of the 'CEN Strategic Plan on services standardization' adopted in the spring 2017. It reflects our wish that work on service standards should respond as a matter of priority to consumer detriment in the crossborder provision of services. The implementation of the strategy is continuing in 2018.



#### **KEEPING HAZARDS IN THE CIRCLE?**

As part of the Circular Economy Action Plan, the EC committed to analyse the interfaces among chemicals, products and waste legislation and recommend policy options. In this context, ANEC contributed to the debate in mid-2017 with a new position entitled 'Keeping hazards in the circle?'

We believe that, for a circular economy approach to be effective, there needs to be a stronger focus on reuse and reduction in the consumption of materials and in the creation of waste. A real commitment to reduce material and energy flows and to develop a strategy to address chemicals in consumer products is crucial to achieve a non-toxic environment for Europe.

#### **REFIT OF CHEMICALS LEGISLATION**

An EC report supporting the Fitness check on chemicals legislation (excluding REACH) was published in March. ANEC had contributed to consultations carried out in the REFIT exercise. The report acknowledges the gaps in legislation for consumer products that ANEC identifies in its strategy. In May, the EC suggested gaps could be addressed in the revision of legislation.

#### **NEW GUIDE ON CHEMICALS**

In July 2017, ANEC welcomed publication of CEN Guide 16 'for addressing chemicals in standards for consumer-relevant products'. It is to help standards drafters address chemicals in standards for consumer-relevant articles, and supports EU objectives to minimise the health and environmental impact of chemicals.

Championed and led by ANEC's Austrian member, the development of the Guide brought together public authorities, industry, environmental organisations, trade unions, research institutes & laboratories; the European Commission and the European Chemicals Agency (ECHA).

#### **ANEC'S CONTRIBUTION TO STANDARDS ADOPTED IN THE TRAFFIC & MOBILITY SECTOR DURING 2017 INCLUDED:**

#### **REVISED STANDARD TO HELP CONSUMER (PEDAL) POWER**

EN 15914:2017 'Cycles - Electrically power assisted cycles - EPAC Bicycles (EPACs)'.

EN 15194 is the European standard dealing with electric power assisted cycles (EPACs in Euro-jargon). ANEC played a leading role in the revision of the standard, adopted in April as EN 15914:2017 'Cycles - Electrically power assisted cycles - EPAC Bicycles (EPACs)'. It should see safer and more reliable EPACs on the roads.

Our contributions to the standard included requirements for reflectors/ active lighting; the brake dimensions; marking of maximum load on the frame; increased stability, and dynamic test procedure based on real-world loads.





#### **ANEC INFLUENCES REGULATION ON CHILD SEATS**

UNECE Regulation 129 on ECRS Phase 3: Universal Belted Integral Child Restraint Systems.

UNECE Regulation R129, providing an enhanced and safe transportation of children in cars, is almost complete. Work started some ten years ago and it will replace R44. ANEC, under the umbrella of Consumers International, has been the sole consumer voice in the discussions.

Phase 1 of the Regulation 129 covering Isofix baby / toddler seats (for toddlers below 105cm), which included our demand for the rearward-

facing conveyance of children to 15 months of age, came into force on 9 July 2013. Phase 2 covering boosters with backrest for children below 135cm (with optional Isofix) was put in place in mid-2017.

In December 2017, the text of phase 3, dealing with belted systems was successful in the first stage of its adoption. It should enter into force in February 2019.

During 2017, ANEC was successful in ensuring approval of group 2 and group 2/3 CRS to the old R44 ends on 1 September 2019. Previously, manufacturers had the choice to comply with R44 or R129. The decision represents another step-forward in protecting children.
