# Less hazardous chemicals in our products For a non-toxic Europe

The EU has set itself the objective to minimise the exposure to hazardous chemicals in our products as part of its overarching goal to create a non-toxic environment.

But effective tools for protecting consumers against hazardous chemicals in products and for reducing the level of toxic substances released into our environment are missing. REACH does not compensate for these deficits. ANEC, the European Consumer Voice in Standardisation, and the Consumer Council of the Austrian Standards Institute are calling for urgent action to establish a framework for hazardous substances in products and rapidly close regulatory gaps in priority areas.

With this event, ANEC and the ASI Consumer Council want to reach out to and foster the exchange amongst EU policy makers and experts, from the European Parliament IMCO and ENVI committees, Commission DG's and cabinet members, and national governments. The objective is to identify the opportunities and challenges for minimising hazardous chemicals in products during this parliamentary term.
